**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE  
BID AND RECOMMENDING THE AWARD OF CONTRACT**

**APPROVED BUDGET FOR THE CONTRACT (ABC): ₱ 10,360,000.00**

**WHEREAS**, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of College Uniforms with an Approved Budget for the Contract (ABC) of ₱ 10,360,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on May 21, 2022;

**WHEREAS**, in response to the Invitation to Bid, five (5) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) on May 31, 2022;

**WHEREAS**, in the public bidding held at the TSU-BC AVR and webcasted via Zoom on June 14, 2022, at 2:00 P.M.:

- (a) three (3) bidders, namely, England Textiles, Zashen Fashions, and Zhujar Manufacturing Incorporation, tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the bids of the three bidders and found the bids to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and were rated "passed";
- (c) the BAC resolved to declare England Textiles, as the bidder with the Lowest Calculated Bid (LCB) for Lot 1 with the bid price of ₱ 4,850,000.00,
- (d) the BAC resolved to declare and Zashen Fashions as the bidder with the Single Calculated Bid (SCB) for Lot 2 with the bid price of ₱ 2,574,400.00,
- (e) the BAC resolved to declare Zashen Fashions as the bidder with the SCB for Lot 3 with the bid price of ₱ 2,839,360.00, and
- (f) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the LCB and SCBs;

**WHEREAS**, in the Post-Qualification Evaluation Conference held via Zoom on August 2, 2022:

- (a) the TWG for Technical Aspect reported that the LCB for Lot 1 was responsive to the technical requirements for the project as prescribed in the Bidding Documents
- (b) the TWG for Technical Aspect reported that the SCB for Lot 2 was responsive to the technical requirements for the project as prescribed in the Bidding Documents,
- (c) the TWG for Technical Aspect reported that the SCB for Lot 3 was responsive to the technical requirements for the project as prescribed in the Bidding Documents,
- (d) the TWG for Financial and Legal Aspects reported that the LCB for Lot 1 was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (e) the TWG for Financial and Legal Aspects reported that upon the verification and validation of the SCB for Lot 2, it was found that the Statement of Single Largest Completed Contract (SLCC) claimed by the bidder was completed beyond the contract period, and due to the delay, the bidder incurred liquidated damages,
- (f) the TWG for Financial and Legal Aspects reported that upon the verification and validation of the SCB for Lot 3, it was found that the Statement of Single Largest Completed Contract (SLCC) claimed by the bidder was completed beyond the contract period, and due to the delay, the bidder incurred liquidated damages,
- (g) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the LCB for Lot 1 as responsive,
- (h) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the SCB for Lot 2 as non-responsive and post-disqualified,
- (i) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the SCB for Lot 3 as non-responsive and post-disqualified, and
- (j) the BAC directed the Secretariat to issue the Notice of Disqualification to Zashen Fashions for Lot 2 and Lot 3 of the project Supply and Delivery of College Uniforms;


**THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:**

- a) to declare the bid of England Textiles for Lot 1 of the project Supply and Delivery of College Uniforms as the Lowest Calculated and Responsive Bid (LCRB) with the bid price of ₱ 4,850,000.00,
- b) to recommend to the President the award of the contract for Lot 1 of the project Supply and Delivery of College Uniforms to England Textiles.
- c) to declare a Failure of Bidding for Lot 2 and Lot 3 of the project Supply and Delivery of College Uniforms.

d) to direct the BAC Secretariat to post the re-bidding for Lot 2 and Lot 3 of the project Supply and Delivery of College Uniforms.
